## For those moving out of Kanazawa City

Thank you for your understanding and cooperation with the administration of Kanazawa City while you were living here. After submitting your moving-out notification, certificates can only be issued at a Kanazawa City Hall counter. (Certificates cannot be issued at convenience stores.)

## About moving out/in using the Individual Number Card (My Number Card) or Basic Resident Registration Card (special provisions for moving in notification)

If you have an Individual Number Card, or if you have filed a moving-out notification together with someone in the same household who has an Individual Number Card, you can file a moving-in notification at the municipal office of your new residence by presenting your Individual Number Card and entering your PIN, even if you have not received a moving-out certificate.

You can also continue to use your Individual Number Card in the municipal office of your new residence. (However, the electronic certificate will become invalid.)

## **Moving-in Procedure**

- (1) Required items
  - (1) Individual Number Card or Basic Resident Registration Card (You will need to enter your PIN when notifying of your moving in)
  - ② Seal of the person making the notification (If someone else is making the notification on your behalf, a letter of authorization is required)
  - (3) Seal and identification document of the person who will be present at the counter (Driver's license, health insurance card, etc.)
- (2) Please submit the moving-in notification within 14 days of the date of moving in and within 30 days of the planned date of moving out.
- (3) Please note that your Individual Number Card will become invalid in the following cases and cannot be used again.
  - ① When 30 days have passed since the planned date of moving out or 14 days have passed since the date of moving in without submitting a moving-in notification.
  - (2) When 90 days have passed since submitting the moving-in notification.

If you fall under one of the following categories, you will need to complete the appropriate procedures. (Please contact the relevant department for details.)

Parents or guardians of children and students attending municipal elementary and junior high schools	Please obtain a certificate of enrollment and a certificate of textbook provision from the school.  Contact: Education General Affairs Section (220-2431)	Please contact the Board of Education of your new residence.

## **★**Changing your moving destination

You may still perform the moving-in procedure even if the moving date or moving destination that you submitted notification for has changed. If you wish to cancel your moving out, please bring your Individual Number Card or Basic Resident Register Card and your seal to Kanazawa City.
